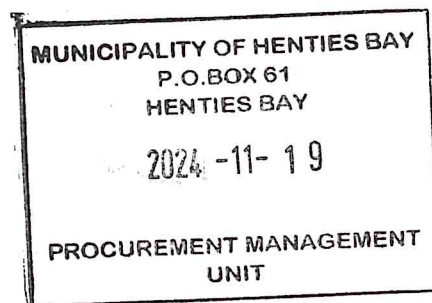

## SECTION I: INSTRUCTIONS TO BIDDERS

### 1. Rights of Public Entity

The Municipality of Henties Bay reserves the right:

- (a) to split the contract as per the lowest evaluated cost per item, or
- (b) to accept or reject any quotation; and
- (c) to cancel the quotation process and reject all quotations at any time prior to contract award.

### 2. Preparation of Quotations

You are requested to quote for the items mentioned in Section III by completing, signing and returning:

- (d) any other attachment deemed appropriate.

The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.

Late Quotations will be rejected.

Note: Quotations received by e-mail will not be considered.

### 1. Opening of Quotations

Quotations will be opened by the Municipality of Henties Bay at Erf 1513 c/o Jakkalsputz Nicky Iyambo Road, immediately after the closing time referred to in instruction 8 above. Bidders or their representatives may attend the Bid Opening if they choose to do so.

Quotations will be opened internally by the Public Entity immediately after the closing time referred to in instruction 8 above. A record of the Quotation Opening stating the name of the bidders, the amount quoted, the presence or absence of a Bid Securing Declaration, will be posted on the website of the Public Entity and available to any bidder on request within three working days of the Opening.

### 2. Evaluation of Quotations

The Public Entity shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of price or ownership cost, subject to Margin of Preference where applicable, to determine the lowest evaluated quotation.
